The P&P service helps patients by implementing expert pain and symptom management, offering integrative treatment modalities such as art, massage, and use of essential oils, providing recommendations for management of distressing symptoms associated with life-limiting illnesses, supporting and enhancing quality of life through individualized care plans, and promoting healing and comfort with a child and family-centered approach.

Each September marks Childhood Cancer Awareness Month and this year, we decided to sit down with patient Arian Redding to talk about her journey with osteosarcoma. Arian was diagnosed in 2015 and began receiving treatment at East Tennessee Children's Hospital. Later that year she came to Pain Consultants of East Tennessee for pain management treatment.

Dr. James Choo performed a spinal cord stimulator procedure and Arian described the results as "helping immensely". Arian



continued her treatment at Pain Consultants of East Tennessee with physical and occupational therapy. Having come into Pain Consultants of East Tennessee in a wheelchair in 2015, she now walks without assistance and stands for long periods of time when working.
